Light Services (Boost, Unlock, Tire Change) \$125.00 + H.S.T.

The use of specialized equipment to relocate/reposition a vehicle \$175.00 + H.S.T.

Mileage charge from scene to destination \$5.00/km

After hour access \$50.00

A different rate can be charged if the vehicle is heavier than 3,175 kg, The rate must be agreed to by the hirer of the vehicle.

TOW TRUCK DRIVERS must:

- 1 not make stops when towing a vehicle to a collision reporting centre or to a destination directed by the hirer
- 2 not charge more than 10% above the authorized amount indicated on this form
- 3 accept e-transfer and credit card payments (all credit card payments for \$100.00 + H.S.T. are subjected to a 2% surcharge)
